We the undersigned understand and agree that:

- 1) The original approved employer agrees to transfer to the new approved employer as from the date of transfer, all rights and obligations under the Memorandum of Understanding – Approved Employer previously registered with NZTR between the original approved employer and NZTR and the Agreement of Apprenticeship, being the individual employment agreement entered into between the original approved employer and the Apprentice Jockey/Probationer.
- 2) The new approved employer agrees to accept such transfer from the date aforesaid, to fully and faithfully perform all the obligations of the original approved employer under the Memorandum of Understanding – Approved Employer and the Agreement of Apprenticeship.
- 3) The Apprentice Jockey/Probationer agrees that as from the date of transfer, he/she will accept the new approved employer as the employer under the Agreement of Apprenticeship for the remainder of the term of that Agreement in all respects as if the new employer were the original employer and that the original employer, as from the date of transfer, shall be released from any obligations to be performed by the employer under the Memorandum of Understanding – Approved Employer and the Agreement of Apprenticeship after that date.
- 4) The Apprentice Jockey/Probationer understands that in accordance with the terms of the Memorandum of Understanding – Approved Employer and the Agreement of Apprenticeship% of any race day earnings will be paid to his/her Employer and the remaining% will be held in Trust by NZTR for the duration of the Agreement of Apprenticeship.
