From the Horse's Mouth

A lot of time is spent by the team at NZTR on strategy. Why? Because one thing that everyone in racing agrees on is the old way isn't working. Everyone has agreed we need to see significant change to create a more sustainable industry.

As we have gone around listening to the various stakeholder groups and talking about the changes that we think need to occur, there are several themes that keep coming across.

There is recognition that the sport of racing needs to innovate if it is going move to a more fashionable and relevant sport in modern New Zealand society.

There is a consistent view from stakeholders that we need to move from a 'racing product' focus to a broader 'business development and innovation' focus if racing is to more deeply engage and appeal to existing and potential customers.

There is acceptance we need one voice and a plan, that we must work together to achieve this and then we might get the legislative changes we need.

We all know that all stakeholders are at risk and the industry is shrinking. Only leadership will help break this cycle.

Over the next few months you will start to hear more about ways NZTR thinks the industry can move forward through new race club partnership agreements, developing our infrastructure at key venues, redefining the brand of thoroughbred racing as a sport, implementing our digital media strategy and specific racing innovations.

I look forward to sharing this with all our stakeholder groups.

New Zealand Thoroughbred Racing noted the decision of the Judicial Committee of the Judicial Control Authority, dated 7 May 2013, where a licensed horse trainer, Mr Leo Molloy pleaded guilty to three counts of misconduct under Rule 340 in relation to the publishing of comments which the Judicial Control Authority deemed to be "abusive...personally insulting and it is hard to escape the conclusion that it was intended to be so."

While NZTR welcomes open debate and fully respects an individual's right to comment on matters relating to the racing industry in New Zealand, persons who hold strong views on governance and administration of thoroughbred racing are entitled to express the opinions they hold. Hhowever, these opinions should be made without abuse or insult. Licensees are reminded of their obligations under Rule 801(1) and Rule 340 in this regard.

Pattern Review Committee Calls For Submissions

New Zealand Thoroughbred Racing (NZTR) recently appointed the Pattern Review Committee to carry out a review of the current pattern and performance of black type racing in New Zealand, with a particular emphasis on Group 1 and Group 2 races, at the request of the New Zealand Pattern Committee. The Pattern Review Committee comprises Mark Freeman, who will chair the review, Gary Chittick, John Wheeler (MNZM) and Neville McAlister.

The Pattern Review Committee, which met on 10 May 2013, is calling for submissions from race clubs, industry stakeholders and any other interested parties on any of the issues identified in its terms of reference including, in particular, on any proposed changes that will enhance the current pattern and performance of black type racing in New Zealand.

The closing date for submissions is Wednesday, 12 June 2013.

The Pattern Review committee intends to make public all submissions received by it.

There will be a further opportunity to comment on the submissions received by the Pattern Review Committee before it releases a draft report for public consultation, which is scheduled to occur in early August 2013.

The Pattern Review Committee intends to provide a final report to NZTR by 30 September 2013. Terms have also been agreed with three photographers - Trish Dunell (North), Peter Rubery (Central) and Colin Berry (South) - to supply copyright-free photos for the purpose of supporting the stories. NZ Racing Board Confirms 2013/14 Racing Calendar

A drive to improve consistency in the provision of New Zealand racing product and to maximise betting opportunities has led to calendar changes for the 2013/14 season.

Following consultation with the three Racing Codes - NZ Thoroughbred Racing, Harness Racing NZ and Greyhound Racing NZ - and clubs throughout the country, the NZ Racing Board has approved the calendar for the upcoming season.

A notable feature of the 2013/14 calendar sees thoroughbred race meetings previously held on Tuesdays shifted to other days. However, Tuesday thoroughbred racing will be held to coincide with feature events - Melbourne Cup Day (November 5, at Ellerslie, Otaki and Wingatui), NZ Trotting Cup Day (November 12, at Palmerston North) and New Year's Eve (December 31, at Stratford).

The 2013/14 calendar, comprising more than 1,050 meetings and 10,800 races, has been devised to best meet the Codes' strategic objectives of optimising domestic and international betting performance.

The majority of traditional race dates for the 2013/14 season remain unchanged from previous seasons.

New Zealand Cup and Show Week in Christchurch will run from November 9 -16.

Next year's Wellington Cup Day meeting will be held on January 25, while the Auckland Cup Week runs from March 1-8.

The Harness Jewels take place at Cambridge on May 31.

A number of domestic racing clubs will again participate in the NZ Racing Board-led Interislander Summer Festival, Christmas at the Races and Mid-Winter Christmas with a record number of events planned in 2013/14.

Riccarton Park Steeplechase - Friday 24 May

As a result of the drainage work being undertaken at Riccarton Park Racecourse, the section of the steeplechase course comprising the two fences known as 'The Racecourse Hotel' and 'Jumbo' is unable to be used at present.

The Canterbury Jockey Club's Special Condition Open Entry "Homeby" Steeplechase over 3200m on Friday 24 May will now, after consultation with the RIU, NZTR and NZ Jumps, comprise 10 fences not 12.

The second fence of the "Stand Double" will be repositioned for this race on the course proper at the 800m adjacent to 'Jumbo'.

Otago Female Riders Race - Sunday 2 June

The Benchmark Rating 65 Fillies and Mares Handicap at the Otago Racing Club's Sunday 2 June will now carry a Special condition with the race restricted to female riders only.

This change in condition has been approved by NZTR and the Regional Programming Committee at the request of the Otago RC to support the Club's "Ladies Who Love Racing" promotion on this day.

May Thoroughbred Racing Monthly - Amendments

Waverley RC Racemeeting - Thursday 23 May

Please note that the meeting on 23 May is inadvertently listed as being an Otaki-Maori RC meeting to be held at Otaki. Track renovations are taking place at Otaki, which gave rise to the meeting now being a Waverley RC meeting being held at Waverley.

There is a consequential distance change with the 2100m distance races now to be run over 2200m.

South Island Meetings from 7 June Onwards - Nomination Fees

The Benchmark Rating 65 and Maiden Races, and a number of 2YO and 3YO races, inadvertently are published with Nomination fees payable, which is NOT correct. These will be DELETED in the June issue.
